

The Monroe County Board of Supervisors met pursuant to adjournment April 23, 2019, with Board of Supervisor members Dennis Amoss (Chairman), John Hughes and Michael R. Beary present.

Minutes of April 16, 2019, read and signed for approval by Board of Supervisors.

Motion by Hughes and seconded by Beary to approve the Monroe County Continuity of Operations Plan as recommended by the Monroe County Safety & Security Committee (SS/CPBS). The Monroe County Continuity of Operations Plan and any information concerning planning and security procedures or emergency preparedness is not subject to public inspection, pursuant to Iowa Code Sections 22.7 (45) & (50).

All voting aye. Motion carried.

Board Chairman Denny Amoss discussed a proposed lease agreement from Rise Broadband. Rise Broadband provides internet services for customers in the area and is interested in leasing space on the Communications Tower at the Monroe County Safety Center. The proposal included an offer of \$500.00 for each of two spots on the communications tower and an offer to provide free internet services to County buildings. Supervisor Hughes wants to ensure that the county would not be decreasing service or strength of connections by switching to Rise Broadband services and would like to know more about Rise Broadband's capabilities. No action taken.

Motion by Beary and seconded by Hughes to approve the Treasurer's Monthly Investment Report as recommended by Treasurer Peggy VandenBerg.

All vote aye. Motion carried.
